

Subscription Agreement

This Subscription Agreement (the "Agreement") is made between the person or entity identified as the "Subscriber" on the associated subscription form (the "Subscription Form") contained on the "Subscription Information" page of the Internet web site www.ArbJournal.com (the "ArbJournal WebSite") and ArbJournal, L.L.C., a Virginia limited liability company ("ArbJournal"). This Agreement takes effect upon the Subscriber's submission of a completed Subscription Form, and the day on which ArbJournal activates the Subscriber's password, and this Agreement is effective as of that date (the "Subscription Date"). The Agreement shall govern Subscriber's access to and use of any and all information, data, reports or other editorial and related material contained in the ArbJournal WebSite.

ArbJournal and Subscriber hereby agree as follow:

1. This Agreement is subject to Subscriber's payment in full of the Subscription Fee specified in the Subscription Form. ArbJournal shall send an invoice for such Subscription Fee, and Subscriber shall pay such invoice in full within thirty (30) days of the date of such invoice. ArbJournal may terminate this Agreement and deny access to the ArbJournal WebSite in the event of deficient payment or nonpayment.
2. As of the Subscription Date and for the Subscription Term specified in the Subscription Form, Subscriber is authorized and licensed to access the ArbJournal WebSite and the information thereon solely for its own internal use and benefit. Subscriber may designate up to five (5) of its employees to access the ArbJournal WebSite, each of which shall have his/her own assigned passwords ("Authorized Users"). Authorized Users may not reproduce (in whole or in part), modify, disseminate, or display information from the ArbJournal WebSite to any others, Subscriber is responsible for ensuring Authorized Users' compliance with the terms of this Agreement, and it shall ensure that no one other than its Authorized Users accesses the ArbJournal WebSite or its contents. ArbJournal reserves all rights not expressly licensed. Any reproduction, distribution or unauthorized use of information on the ArbJournal WebSite not authorized by this Agreement is strictly prohibited.
3. Subscriber agrees not to take any action that would interfere with the operation of the ArbJournal WebSite, and not to attempt to access or download its contents without authorization.
4. Subscriber acknowledges and agrees that ArbJournal owns all rights, title and interest in the ArbJournal WebSite and its contents, including all proprietary and intellectual rights. Access to the ArbJournal WebSite is licensed on a confidential basis, and the contents of the ArbJournal WebSite are copyrighted and trade secret subject matter owned exclusively by ArbJournal. Subscriber agrees to keep all information contained in and provided by the ArbJournal WebSite confidential, including without limitation, Subscriber's and Authorized Users' passwords.

Subscriber agrees to the terms and conditions contained in the [Legal Disclaimers](#) and [Privacy Policy](#) posted on the ArbJournal WebSite, which terms and conditions are incorporated by reference. The terms of the this Agreement may change from time to time, and any such changes shall be posted in the [Legal Disclaimers](#) or [Privacy Policy](#) sections of the ArbJournal WebSite. Subscriber agrees to regularly review these sections of the ArbJournal WebSite, and subsequent access to and use of the ArbJournal WebSite by Subscriber or its Authorized Users shall constitute Subscriber's agreement to such additional or different terms.

ARBJOURNAL MAKES NO REPRESENTATIONS OR WARRANTIES AS TO ANY RESULTS TO BE OBTAINED FROM USE OF THE ARBJOURNAL WEBSITE, THAT THE SERVICE WILL BE UNINTERRUPTED OR ERROR-FREE. OR THAT THE INFORMATION CONTAINED IN THE ARBJOURNAL WEBSITE WILL BE COMPLETE OR ACCURATE.

8. IN NO EVENT SHALL ARBJOURNAL'S TOTAL MONETARY LIABILITY IN CONNECTION WITH THIS AGREEMENT AND THE ARBJOURNAL WEBSITE, UNDER ANY LEGAL THEORY, EXCEED THE TOTAL AMOUNT PAID BY SUBSCRIBER TO ARBJOURNAL IN THE SUBSCRIPTION TERM DURING WHICH SUBSCRIBER'S CLAIM ACCRUED.

9. Subscriber agrees to indemnify ArbJournal and hold it harmless against all claims, causes of action, liabilities, damages and expenses and costs (including reasonable attorney's fees) arising in connection with any third-party claim against ArbJournal in connection with Subscriber's use or inability to use the ArbJournal WebSite or any decision or actions in connection with such use.

10. Payment of the Subscription Fee entitles Subscriber to access the ArbJournal WebSite for the Subscription Term specified in the Subscription Form, beginning as of the Subscription Date. This Agreement shall automatically renew for additional renewal term of equal duration, provided that Subscriber timely pays ArbJournal's invoice for the renewal Subscription Fee. The Subscription Fee may change upon renewal, and ArbJournal may require agreement to modifications to this Agreement as a condition to renewal. Subscriber may terminate this Agreement by allowing the annual subscription to expire, or by notifying ArbJournal in writing of its election to terminate (in which case Subscriber must cease all access to the ArbJournal WebSite). Either party may terminate this Agreement in the event of a material breach of this Agreement by the other. ArbJournal, LLC reserves the right to terminate the Subscriber's password and access to the Website and to cancel the Subscriber's Subscription at any time, without refund, in the event ArbJournal, LLC believes, in its sole discretion, that Subscriber is in breach. Upon termination or expiration, all rights and licenses to access and use the ArbJournal

WebSite shall cease. Provisions of this Agreement that, by their nature, survive the termination or expiration of this Agreement (including without limit obligations of confidentiality), shall so survive.

11. This Agreement is the entire agreement between ArbJournal and Subscriber with respect to the subject matter of this Agreement. This Agreement can be modified only as provided for herein, or by a written instrument signed by duly authorized representatives of each party. This Agreement shall be governed and construed on accordance with the laws of the Commonwealth of Virginia, without regard to its choice of law rules. Should any provision of this Agreement be finally held to be invalid, void, unenforceable or otherwise contrary to law or equity, the offending provision shall be reformed automatically as necessary to cure the deficiency, or if necessary deleted, and the remainder of this Agreement shall have full force and effect.
